Four-year program report: 2020-24

October 2024





It has been four years since the inception of the Data Profession, and I am thrilled to see its initiatives have continued to progress over the past 12 months. We have continued to build on the initiatives of the first three years and I'm pleased to see several projects delivered in year four.

I am delighted to see continued interest from prospective graduates in having careers in data in the public sector. The 2025 APS Data Graduate recruitment program saw over 1,760 applications and 43 agencies seeking around 300 data graduates.

In the first year of the Data Profession the SES Data Leadership course, which builds foundational skills for the SES, was piloted. It was offered in 2022, 2023 and 2024 and has been attended by 192 SES staff from 26 agencies. Following the SES Data Leadership Course, a similar course for the EL2 cohort commenced this year. There have been two offerings including a pilot so far and the course will run through 2025.

The Data Profession Members' Community Platform, the web-based platform for data professionals to learn about events, job opportunities, communities of interest and resources relevant to their work, continues to grow. Since its establishment in August 2022, it has grown to over 10,800 members. Also on the platform are my *In Conversation* videos in which I interview people for whom data plays a big role in their careers. I encourage all public sector data professionals to sign up to the platform.

I look forward to further development of the Data Profession in the year ahead and thank all our partner agencies for their collaboration.



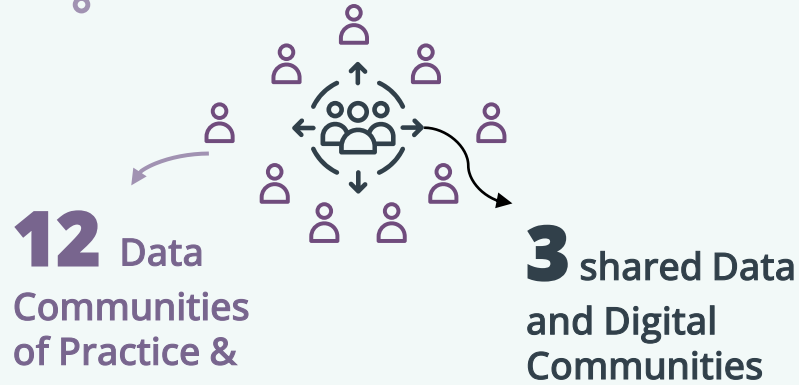

Since launching in August 2022, the MCP has grown significantly.



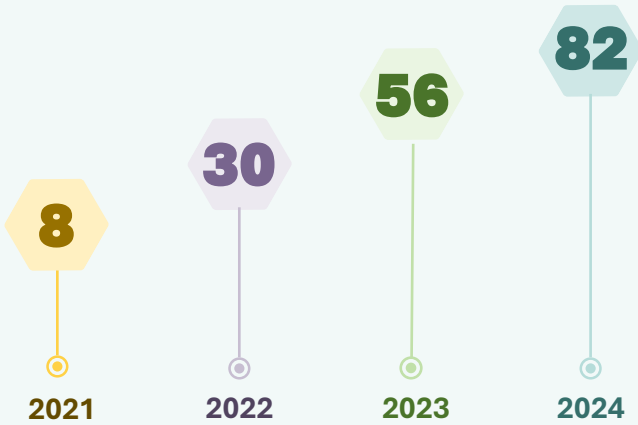

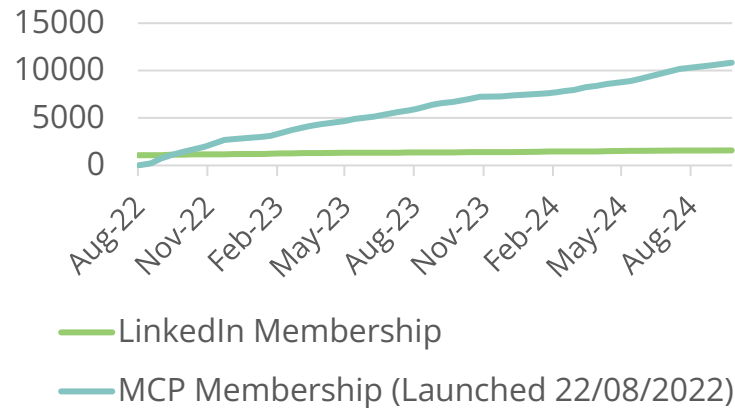

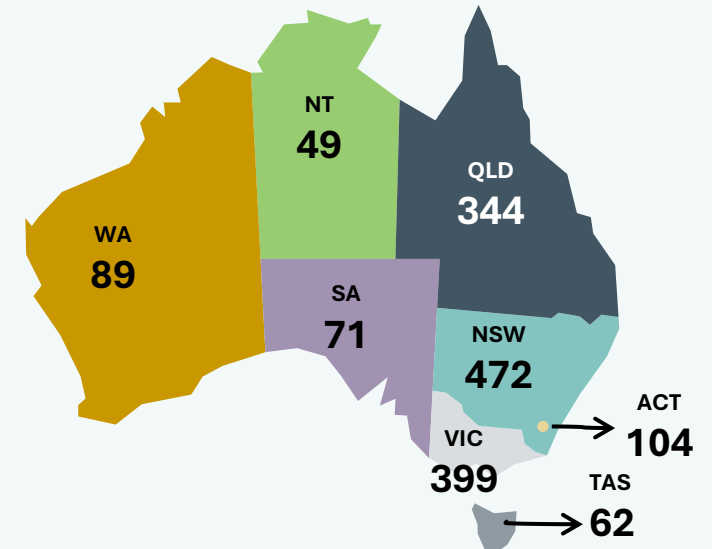
An increasing number of agencies have engaged with the Data Capability Framework Community of Practice.

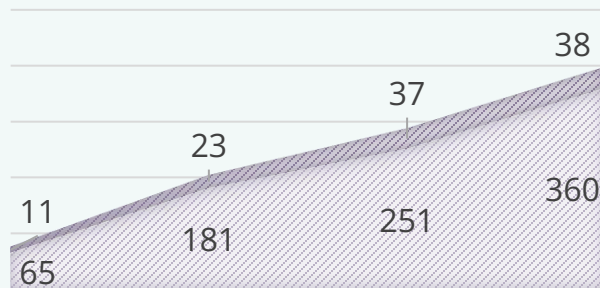

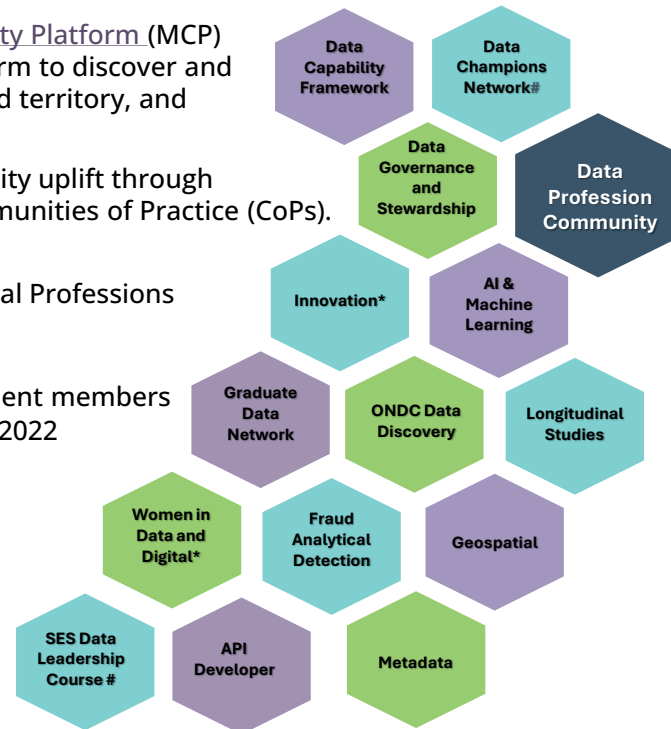

2025 Australian Government Graduate Program Data Stream

The Data Profession is in its fifth year of streamlining data graduate recruitment across the APS as part of the [Australian Government Career Pathways program](#).

The initiative aims to build data capability in the APS by growing the Data Profession at the entry level. It also provides an opportunity to leverage common talent pools between Data and Evaluation Professions.

At a glance

- ✓ The ABS continues to lead APS data graduate recruitment for the 2025 intake
- ✓ 10 streams through which data graduates can enter the APS
 - 1 generalist stream
 - 9 specialist streams, including data
- ✓ 1,761 applications received for the data stream, most of all the specialist streams
- ✓ 300 data graduates forecast to be placed across 43 agencies
- ✓ 583 candidates in the merit pool with approx. 240 confirmed placements so far
- ✓ Established the Evaluation Stream which shares common talent pools

Embedding a professional data workforce

The Data Profession aims to support the data workforce with an up-to-date Data Capability Framework and by providing examples of data professional career pathways.

Developing sophisticated and specialist data capabilities initiatives

The Data Profession builds data capability across the APS through foundational product offerings, data literacy and leadership courses, and spotlighting data professionals at various stages of their careers.

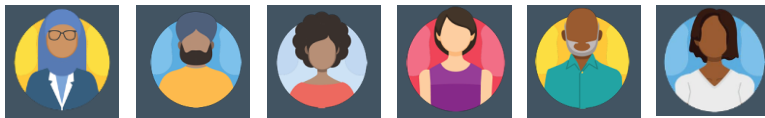

Introduction to data in government course for APS data graduates

- ✓ Course delivered to over 200 data graduates from 38 agencies
- ✓ Selected modules delivered through the APS Graduate Development Program with 314 participants from 24 agencies
- Following feedback, the course will be transformed into an e-learning package and offered to all APS staff via APSLearn as a refreshed data literacy course from early 2025

Expanded Data Job Role Personas

- ✓ A project team from the Australian Taxation Office updated the suite of [Data Job Role Personas](#), adding 6 personas
- ✓ The new personas are Data Steward, Data Project Manager, Data Governance Officer, Metadata Specialist, Data Architect, and Data Translator

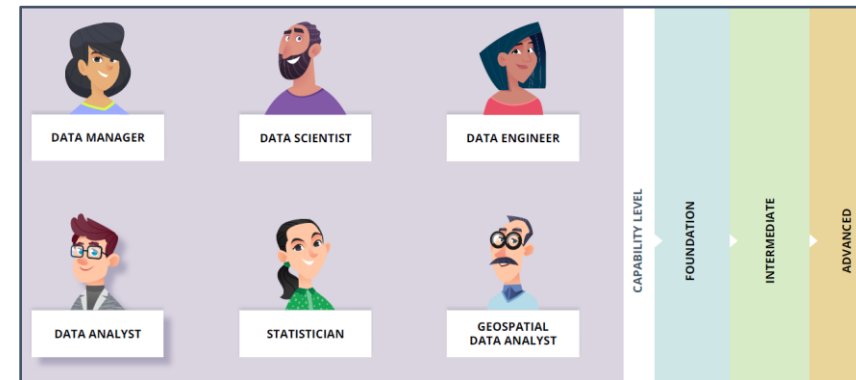
